CLUB MEMBERSHIP

(AND PLAYER SELECTION FOR COMPETITIVE GAMES POLICY)

LUTON TOWN WFC LADIES (also known as **LUTON TOWN WALKING FOOTBALL CLUB LADIES/LTWFC LADIES**), herein after referred to as "the Club." The Club is an unincorporated, non-profit entity, formed by an agreement between individuals to pursue a shared purpose which is:

To play, promote and enjoy walking football as a sport, a recreational activity, an organisation to meet and make new friends both on and off the field of play and to provide an environment that encourages the pursuit of fair-play, fitness and wellbeing.

As a non-profit club, we are self-financing via:

- **CLUB MEMBERSHIP**
- **PLAYER SUBSCRIPTIONS**
- **SOCIAL EVENTS & FAMILY GATHERINGS**
- **CLOTHING/MERCHANDISE**
- **SPONSERSHIP**
- **GRANT FUNDING**

Our coaches, managers, committee members or volunteers do not receive payment for the services and time they provide to the club. The revenue streams listed above as sources of income, help finance the club and all its activities on and off the field of play.

An important income source (as detailed above) is our Club Membership; the fee is currently:

£25 payable in September (or pro-rata prior or after September)

This membership fee provides additional finance for player and club insurances, both of which are required for our duty of care, FA Accreditation and club administration processes. As from **Monday 13th April 2026** and as published in the committee minutes relating to that date, this Club Membership is now a requirement for all players who wish to represent the club in all competitive matches to include:

- Tournaments
- League Fixtures
- Friendlies

As a result of that Monday 13th April 2026 committee meeting, the player selection process has also been amended and will now include (since those minutes were published), the following caveat (**in red**) regarding valid Club Membership:

“THE BEST PLAYERS MAY* BE SELECTED TO REPRESENT THE CLUB FROM THE PLAYERS AVAILABLE ON MATCH DAY, EVEN IF THOSE PLAYERS WERE NOT AVAILABLE FOR SELECTION PRIOR TO LEAGUE OR TOURNAMENT REGISTRATION. PROVIDING, THAT THEIR MEMBERSHIP IS UP TO DATE AND VALID”.

UNPAID MEMBERSHIP FEES WILL DISQUALIFY PLAYERS FROM LEAGUE OR TOURNAMENT SELECTION AS WILL NON-PAYMENT OF SUBSCRIPTION FEES**

PLEASE ALSO NOTE THAT THIS MEMBERSHIP DOES NOT GAURANTEE COMPETITIVE TEAM SELECTION.

*May: dependent on league/tournament organisers permitting late changes or additions to submitted team/squad lists and the current committee approved, team manager's discretionary selection process.

**Subscription fees refer to the monies agreed by the club and its members for training and free play, currently collected via monthly direct debit. Tournament 'only' players, those who do not train regularly with us, but who are selected when availability is low or additional 'playing ability' is required, pay a separate 'tournament' fee.
